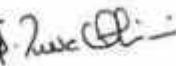
4 OBJECTS

e) Nothing contained in this deed, shall be deemed to authorize the Board members to do any act which may be in any way be construed as volatile or contrary to the provisions of section 2(15), 11, 12, 12A, 13 and 80G of the Income Tax Act 1961, or any statutory modifications thereof and all activities of the Trust shall be carried out with a view to benefit the public at large without any profit motive and in accordance with the provisions of the Income Tax Act 1961 or any statutory modifications thereof. The surplus funds, if any of the Trust shall be invested in accordance with the provisions of the Income Tax Act 1961 as amended from time to time.

f) One or more Bank accounts may be opened in scheduled Nationalized Banks in the Name of the Trust and the Managing Trustee shall operate the same jointly with the secretary of the Trust.

g) To sell or otherwise transfer or change the assets including immovable for advantageous and on behalf of the Trust.

h) To borrow money on behalf of the Trust and after any of the assets of the trust as security in respect of such borrowings.

c) To do all such acts and deeds as may be necessary for the proper conduct of the trust.

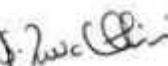

i) To provide school/college fees to all poor people, it should be done through Cheque payment only to their respective educational Institutions in order to develop their higher Studies without any hindrances.

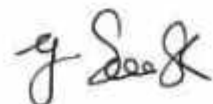
9 POWER OF OFFICE BEARERS MANAGING TRUSTEE

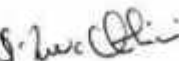

12 IRREVOCABLE CLAUSE

While this Trust shall be irrevocable the board of Trustees may amend any of The clauses except those relating to objects of the Trust, the managing Trustee, at a duly convened meeting of the Board and by a resolution passed By majority of the Trustees only or by circulating among trustees

13 PROCEEDINGS OF THE TRUST

a) The General Body of Trust comprising all Trustees shall meet once in a year to adopt the following resolutions:

- ii) To appoint a qualified Chartered Accountant as auditor for the next year.

b) The quorum for the meeting shall be Three.

c) Every Meeting of the Trustees shall be presided over by the Managing Trustee of the Trust.

d) Points of disputes shall be decided by the vote of the majority either by show of hands or by ballot as may be rules adopted by the Managing Trustee. The Managing Trustee himself/herself shall have a casting vote which he/she may exercise or not at his/her will. Attendance of members by proxy is prohibited.
